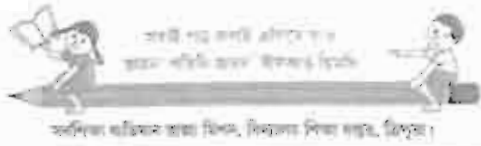

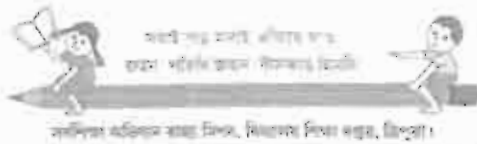

Terms and Conditions in respect of submission of Expression of Interest (EoI)

1. The last date of receiving expression of interest is upto 4:00 pm on 30th April, 2011.
2. The agencies should have experience in making short films / documentary films etc. at least for 5 (five) years. Certificates of experience from Govt. recognized institutions in India also to be submitted with the expression of interest.
3. Atleast copies of Sale / Income Tax Clearance Certificates and Registration of the firm valid upto date, Organizational Profile etc. should have to be submitted along with expression.
4. The cost of preparation of sample of demonstration and the cost if any, for demonstration will be borne by the agency.
5. An estimate of charges should be quoted in words and figures.
6. The authority reserves the right to accept or reject any expression without showing any reason.
7. Sample of similar works of the Agencies carried out earlier should also be submitted along with the EoI.
